

HANDEPAY REWARDS PROMOTION JUNE 2024

These Terms and Conditions (“**Terms**”) govern this random draw to win 12 months’ free terminal rental or Love2Shop e-Gift Cards offered by Handepay Ltd (“**Handepay**”, or the Promoter) to all eligible participants from 3 June to midnight on 30 June 2024 (“**Prize Draw Period**”).

Please read the following Terms carefully and keep a copy for your information.

1. Eligibility

In order to be an eligible participant for the Prize Draw, you must be a merchant who

- (a) receives card acquiring, terminal leasing and/or e-commerce and virtual terminal services arranged by or through Handepay; and
- (b) completes registration to become a member of the Handepay Rewards scheme.

2. Details

Merchants who meet the eligibility criteria above shall be entitled to enter into a prize draw (the “**Prize Draw**”) for the chance to win the following prizes:

- First Prize – 12 months free terminal hire for one (1) terminal.
- Runner Up Prizes – three x £50 Love2Shop e-Gift Cards.

(together, the “**Prizes**”)

3. How to Enter

3.1 To be automatically entered in the Prize Draw (an “**Entry**”), by midnight on 30 June 2024, you must:

- Register for your Handepay Rewards Membership at www.handepayrewards.co.uk
- Have completed one successful card transaction via your card acquiring service arranged by Handepay.

3.2 Only one entry shall be made per merchant business. Any Entries after the Prize Draw Period has ended will not be valid and as such, will not be entered into the Prize Draw.

3.3 By entering the Prize Draw you agree to be bound by these Terms and that you are not restricted from complying with these Terms in any way.

4. Prize Draw and Prizes

4.1 The Prize Draw will take place on 4 July 2024 and one First Prize winner will be chosen with three Runner-Up Prize winners (together the “**Winners**”), by a random draw performed by a computer process.

4.2 The Winners will be notified by email on 4 July 2024 and must respond within 7 days from receipt of the email in order to claim their Prize.

4.3 If a Winner does not respond within 7 days to claim their prize, then the Winner’s prize will be forfeited and Handepay shall be entitled to select another winner in accordance with this Clause 4.

4.4 The Prizes will be distributed or applied within 14 days of confirmation under clause 4.2 above.

5. Other Important Terms

5.1 Handepay is acting as the promoter of the Prize Draw, and as such maintains responsibility for administering all aspects and all stages of the Prize Draw.

5.2 Responsibility is not accepted for any Entries that are deficient, lost, damaged or delayed as a result of any computer hardware, network or software failure of any kind, or any other form of technical fault, including illegible or unclear writing or images. Handepay reserves the right to reject any Entry in its sole discretion.

5.3 Handepay reserves the right to verify the eligibility of all Entries and may, in its sole discretion, refuse entry or refuse to reward a Prize if the Winner fails to satisfy any eligibility requirements set out in these Terms or where we suspect that a false or fraudulent submission is being made or misleading information has been given.

5.4 Handepay does not accept any liability if a Prize is lost or delayed, howsoever caused.

5.6 The Prizes shall be gifted to the Winner’s merchant business as a whole, not the manager or owner of the business.

- 5.8 The 12 months free terminal lease which is the subject of the First Prize is subject to its own terms and conditions with Merchant Rentals Limited, the terminal leasing provider. The First Prize Winner shall continue to be bound by the terms and conditions associated with their terminal lease agreement and Handepay shall not be responsible for any costs associated with it or its termination as the case may be.
- 5.9 The Prizes are non-transferable, non-exchangeable and no cash alternative is offered. Handepay accepts no responsibility for any costs associated with the Prizes and not specifically included in the Prizes (including any tax or other fees).
- 5.10 If the First Prize Winner terminates their terminal lease before the end of the 12 months for the prize, no cash payment shall be made for the remaining months.
